Thank you for giving one of our dogs a loving home. Our dogs have often been abandoned, neglected and/or abused. We rarely know their full history or the conditions under which they have been trained, therefore we can give no assurance on any aspect of their temperament or long-term physical condition. We have followed any veterinary advice given and will share this with you. The dog has been microchipped and will remain registered to Greyhound and Lurcher Welfare and Rescue.

**I, the undersigned, will be the new owner of this adopted greyhound/lurcher and will, at all times, adhere to the requests laid down by Greyhound and Lurcher Welfare and Rescue (GLWR) in that I, the owner:**

- Will give the dog a good, loving and caring home and promise that he/she will not be used for racing, rabbiting or hunting of any description or be sold, given away or abandoned
- Will inform GLWR without delay if circumstances arise that mean I am unable to keep the dog in the agreed manner and will arrange the return of the dog forthwith
- Will, at all times, ensure that the dog wears a house collar and identity tag and will inform GLWR, the local police and animal wardens immediately if the dog should go missing, taking all possible steps to find and retrieve the dog
- Will keep the dog fully vaccinated and wormed throughout its life and seek veterinary advice when needed
- Will make adequate provision for the dog should it be left unattended
- Am aware of the special responsibilities of owning a sighthound that has been trained to chase, and will not allow it to worry or be a nuisance to livestock or small animals

- Understand that I am liable for all damage caused by this dog as a result of accidents, negligence or incompetence
- Am willing for a GLWR representative to visit the dog and check on his/her welfare at any reasonable time. If the representative considers the conditions under which the dog is being kept are unsatisfactory I will allow the animal to be repossessed immediately by that GLWR representative
- Agree that I am responsible for all veterinary fees for this dog from the date of adoption. I have been made aware of the benefits of private veterinary insurance
- Understand that the adoption fee is non-refundable
- Have read and understood all the conditions laid down in this document
